With reference to the notification vide Ref. No.KLEU/18-19/D-1169(B), dtd: 7thAugust 2018, the Counseling/admission process in respect to Post Graduate MD/MS Ayurveda for the academic year 2018-19.

The counseling shall be conducted as follows:

A. SCHEDULE OF ADMISSION PROCESS

1. The admission process will be conducted for **MD/MS Ayurveda on Saturday, 6th October 2018 at KLE Academy of Higher Education and Research , Jawaharlal Nehru Medical College Campus, Nehru Nagar, Belagavi – 590010.**

Note: The duration of the admission process may exceed the above schedule time due to various reasons, the Deemed University shall not be responsible for the delay in the admission process and the consequences there upon including pre decided travel schedule of the parents/applicants, if any

Counseling Process:

1. It is mandatory for all the candidates to register their name at the beginning of the counseling session by signing in the register kept at the registration counter. Those of the candidates who report for registration at the registration counter **after 12:30 pm** in morning session will be taken for counseling at the end of respective counseling session on that day.
(Registration for morning session starts at 10.30 am)
2. Failure to report for counseling on the scheduled date and time will result in instantaneous cancellation of a claim of the candidate to the seat.
3. The candidate should remain present for the counseling & for on-the-spot admission, as per the schedule displayed on website, even though he/she fails to receive any information letter, for any reason from the University.
4. Only the candidate & one of his parents/guardian will be allowed into the hall where counseling is held. The candidates will be called in the order of their ranking in the merit list & offered the seats to the various courses available at that point of time. The candidate will be allowed to choose admission to any of the courses if a seat is available when his/her turn comes.
5. The candidate must note that inclusion of name in the Merit List does not necessarily mean that he/she will get admission to any course. His/her admission to a particular course will depend upon the availability of seats for that particular course at the time of his/her counseling.

CANDIDATE SHALL ARRANGE ABOVE DOCUMENTS IN THE ORDER ASPER CHECK LIST PROVIDED AT ATTENDANCE DESK.

1. Candidate shall report at Document Verification Desk along with Originals & two sets of photocopies as per Check List.
2. Candidate shall report to Scrutiny officer who shall validate the Check List & sign with seal. Scrutiny Officer shall issue Token, permitting the Candidate to proceed for Counseling.
3. Candidate shall report to counseling hall along with TOKEN & Original Documents photocopies & Demand drafts for Tuition fee.
4. Candidate shall report for counseling by the Central Admission Committee for opting available seat/ wait-list.

COUNSELING / SEAT SELECTION:

The candidates will be called on merit-wise & may opt for any of the available seats / subjects at the time of counselling with following options.

- The candidates can **only opt** for seat or **may not opt**.
 - The candidates **opting for a seat** may also **opt for waiting list** number.
 - The candidates may opt for **only waiting list** number.
5. Candidates with Provisional Allotment letter shall report to the fees collection counter along with Online transfer acknowledgement / Demand Drafts (of Nationalized / Scheduled Bank) for fees receipt.
 6. Eligibility for admission will be as per respective regulating council and by the university for respective course.
 7. Candidate with **Seat not allotted but wait listed** shall also report to Admission /fee collection counter & deposit (refundable) Online transfer acknowledgement/ DD of **Rs. 50,000/- (Rupees Fifty thousand only)** drawn in favour of "The Registrar, KLE University, Belgaum, Payable at Belagavi (Belgaum)"& take acknowledgement.
 8. Candidates **Seat not allotted and not wait listed (Not opted)** shall take back their Original Documents & DD's by submitting '**Not Opted**' allotment letter Signed by the Chairman, Central Admission Committee.
 9. In case of any confusion or any other matter arising out of Counseling Process ,the decision of the Central Admission Committee shall be final.
 10. Eligible candidates who appear for counseling will be allotted either a seat or waitlist number depending upon the availability of the seat / wait-list at that point of time and also upon candidate's desire, during the counseling.
 11. Those of the candidates desirous of keeping their name in waiting list for **MD/MS Ayurveda** have to mandatorily deposit a minimum amount of **Rs. 50,000/- (Rs. Fifty thousand only)** with the University.

Candidates are informed to keep visiting our website frequently for allotment of seat against vacancy if any.

12. Original documents will not be given back to candidates once a candidate joins the course. If a candidate wish to take back their original documents after joining the course, shall do so by surrendering the seat allotted to him/ her.

Refund Policy:

If a student submits application for cancellation of allotted seat in the prescribed form –

- An amount of Rs.10,000/- will be deducted in case of cancellation of seat by 31st of October 2018
- Entire course fee is to be paid by the candidate in case of cancellation of seat after the last date of admission i.e. 31st of October 2018.
- Eligibility Fee (Not refundable)
- *Note: In case of refund of fees against cancellation, the amount will be credited to candidates account only with valid PAN number.*

- **The course will be commencing from 5th November 2018.**

D. HOSTEL ADMISSION :-
