The KAHER has been reviewing creation, maintenance and utilisation of physical, academic and support facilities at the respective campuses from time to time, keeping in view the norms of the respective UGC and Regulating Councils.

The University and the respective Colleges have individual Departments like Civil Engineering, Electrical Engineering, etc. with supportive staff for development and maintenance of various infrastructures like Administrative Block, recreational facilities, cafeteria, Auditorium, Sports Complex, Hostels, Wi-Fi, Quarters, Lecture Halls, Research Centres, maintenance of garden, etc. in the respective campuses.

The Registrar of KAHER and the Principals of the constituent units have been delegated with the powers of approving expenses for maintenance of physical, academic and support facilities at University level and College level respectively. Any expenses which exceed the delegated powers of the Registrar and Principals, such proposals are being placed before the Purchase Committee / Finance Committee / Board of Management of the University for necessary approval.

The KAHER has framed Memorandum of Association (MoA) as per the UGC (Institutions Deemed-to-be-Universities) Regulations and the same has been registered with the Registrar of Societies, Belagavi. As per the MoA, the KAHER has constituted various Boards and Committees and the meetings of the same are being conducted at regular intervals. All the Boards and Committees of KAHER are chaired by Hon. Vice-Chancellor.

The matters relating to availability and maintenance of infrastructure and funding for such infrastructure are being deliberated from time to time in the concerned meetings viz. Building & Works Committee, Purchase Committee, Planning and Monitoring Board, Board of Management, etc. and appropriate decisions are taken to facilitate creation of infrastructure and consider financial grant for the same. The proposals include undertaking new major / minor civil works, alteration of existing civil works, procurement of furniture and equipment, Annual Maintenance of equipment, computers including hardware and software, replacement of old equipment with new / modern equipment, etc.

The KAHER after ascertaining the need and requirements from the individual Heads of the Departments / Institutions, has been making necessary budgetary provision for the same every year. After placing and approving the Annual Budgets by the Finance Committee and Board of Management, the individual Departments and the Institutions will plan for creation of facilities and utilization of budgets.
