

REVISED GUIDELINES FOR INCENTIVES FOR PUBLICATION BY THE FACULTY MEMBERS WORKING IN THE CONSTITUENT UNITS OF THE UNIVERSITY

- a) The faculty members shall forward their applications in the prescribed application to the University through proper channel.
- b) The University shall consider grant of incentives based on the guidelines / recommendations of the Sub-Committee of the Publication Board of the University.
- c) The University reserves right to revise / alter / modify the policy relating to grant of incentives for publications.
- d) The Principals shall make necessary entries in the Service Registers of the concerned faculty members at the institution with regard to publications.
- e) Only original research articles shall be considered for grant of publication incentives.
- f) **Grant of incentives is applicable for publications in the following:**

Scientific Articles published in:	Grant eligible
For publication of a scientific article in an indexed peer reviewed journal as the first author or corresponding author (Publication in SCI Index, UGC-CARE, Pubmed, Web of Science and Scopus) The incentive will also be given to other authors in case of multicentric studies, in high impact journals (with minimum impact factor of 1.0 Thomson Reuters) and fulfilling other indexing criteria	Rs.10,000/-
Chapter contribution in Text Book	Rs.6,000/-
Sole Author of Text Book / Reference Book	Rs.9,000/-
Short Communications / Letter to the Editor / Clinical Commentary / Other correspondences like Picture of the month	Rs.2,000/-
