- Item 1 : Minutes of the previous meeting held on 19.02.2021 were read and confirmed.
 - Director Academic Affairs suggested that the course content should be under domains of Cognitive (Theory), Psychomotor (Practical) and Affective (Ethics/ Communication Skills/ Professionalism etc.)

- Item 2 : Repor

: Reporting of the online/offline teaching conducted for undergraduate students in last 6 months & discussion of the feedback:

All the members reported about the classes conducted in online & offline mode during the lockdown and post lockdown period. Members expressed that attendance was very low in off-line classes. Principal informed that the I BDS students will not have any vacations and their classes will commence immediately after the final university exam. It was suggested that extra practical classes be conducted for the students in the subject of Dental Materials, pre-clinical Conservative Dentistry and Pre-Clinical Prosthodontics to compensate for lack of hands-on training during lockdown period.

Item 3 : Reporting of the progress of Integrated Teaching Learning (ITL) classes in all the subjects and to discuss about the newer topics to be included:

- Integrated classes are regularly being conducted for specified topics in Gen Anatomy & Gen Physiology and Gen Pathology, Microbiology & Pharmacology.
- Topics identified in the subject of Dental Materials for integrated teaching by department of Conservative Dentistry & Prosthodontics are conducted on regular basis.

• ITL classes are conducted in Dental Anatomy along with Gen. Anatomy

The members reported that ITL classes are incorporated in the curriculum and are conducted on regular basis except for the present batch where due to lockdown some changes had to be made in the time table.

It was discussed that some of the topics that are mentioned under ITL in the curriculum are not relevant for ITL and can be changed to conventional teaching

methods. It was suggested that the concerned departments have to once again discuss and arrive at a decision whether to have ITL or not for topic of concern and to include any new topics if needed.

Item 4 : To discuss regarding implementation of newer Teaching-Learning and assessment methods:

Newer teaching-learning modalities to be implemented along with Integrated Teaching Learning, Flip Classroom, Small Group Discussion, use of Checklist & Rubrics were discussed:

- Use of ICT enabled tools such as small group assessment using google classroom to be implemented.
- For early clinical exposure a visit to the skill labs & museums should be planned.
- It was suggested to have more of interactive learning sessions such as SGT (small group teaching) & SDL (self-directed learning) and less of didactic teachings to make learning more students centric.
- Item 5 : To develop a feedback mechanism for the curriculum:
 - All departments are regularly obtaining feedbacks from peers, students, parents and patients.

To have uniformity in feedback process, the university is in the process of developing a feedback form for all faculties. Any change in the curriculum suggested through the feedbacks will be further discussed in Board of studies and Faculty meetings. It was informed that only 20% change will be accepted in each revision.

Item 6 : Regarding course-content on the topic of 'SARS' (to be included in the chapter of 'Communicable Diseases'):

The topic of SARS will be included in Virology section in the subject of Microbiology. This will be taught in integration with Gen Pathology. The course

Step;1 General need assessment

Clinical Microbiology is an important branch of Medicine, catering to the diagnostic needs and forming one of the leading branches which have significant bearing on human health and patient care. There is a need of change of PG curriculum because there is a changing trends in occurrence of disease and vast expansion of advance diagnostic technology. Hence the knowledge of the Microbiology can be used in a variety of clinical settings to solve diagnostic and therapeutic problems and to undertake teaching assignment of Microbiology.

Current approach; Present curriculum for PGs is through Lecture class, Journal club, case based studies and clinical workup on a given scenario under supervision. The presentation of the students is evaluated by all the faculty in the form of checklist.

Ideal approach; Clinical postings, patient supervision and follow up is required for the PG teaching. PG should be trained in control of Nosocomial infections and Hospital waste management in Real time at Hospital.

2. Targeted need assessment;

Targeted students; PG students of Microbiology labs.

After completing the training in Medicine, the students will enter Microbiology with basic knowledge in good patient care and prevention of infectious diseases and certain skills of microbiology techniques. Current curriculum for PGs is through Lecture class, Journal club and case based studies and clinical workup on a given scenario under supervision. The presentation of the students is evaluated by the entire faculty in the form of checklist.

In this connection we need to focus on, adequate infrastructure and separate laboratory for the PG students for the training, Training in Hospital acquired Infection control & Bio - Medical Waste Management, Antibiotic Stewardship for the hospital along with Molecular Microbiology work. Some of the topics in microbiology are obsolete (like Animal experiment, phage typing, conjugation experiment etc) and required to be deleted from the syllabus.

3. Goals and competencies

Goal; To be a competent Clinical Microbiologist.

Competencies; PG should be able to:

- Manage laboratory and procedures with advanced technology.
- -Manage UG teaching
- Selecting the appropriate investigation for the diagnosis.
- PG should be trained to take up job as Infection control specialist, Molecular -Microbiologist, CSSD Specialist along with consultant Microbiologist.



With One subsidiary subject is to be included in each semester.


