As per the norms of the MCC/DGHS/Government of India, Admissions to Under-Graduate (MBBS/BDS/BAMS/BHMS), Post-Graduate (MD/MS/MDS/PG Diploma) & Super Speciality (DM/M.Ch) programs will be based on the ranks obtained by the candidates in the National Eligibility Cum Entrance test (NEET) with Online counselling & seat allotment by the Medical Counselling Committee (MCC) for medical courses / AYUSH Admission Central Counselling Committee (AACCC) for AYUSH courses from the academic year 2016-17.

As per the norms of the Ministry of Education, Government of India, admissions to Under-Graduate and Post-Graduate programs / courses in B.Pharm, M.Pharm and Allied Health Science are done through Study in India Scheme, based on the seat allotment by the Government of India from the academic year 2019-2020 and after due verification.

Standard Operating Procedure:

The Committee shall:

- a) Students to be appraised of the admission process for various academic programs / courses based on the guidelines issued by the Government of India, UGC and the respective Regulating Councils.
- b) Students are to be guided with regard to enrolment, functioning and role of the Committee and share with them the contact details in case of grievance / emergency.
- c) Students are to be guided with regard to academics, co-curricular, extra-curricular, admission, evaluation or any other issues during their stay in the Institution / Campus.
- d) Indian & International students with the qualifications obtained from Indian/foreign board/university, to its undergraduate (UG), postgraduate (PG) and Super Speciality (SS) programs in Health Sciences, based on the qualifications recognized by the Association of Indian Universities (AIU), New Delhi.

- e) On confirmation of admission, the International Admission Office issues a letter to the student to obtain a Student Visa from the Indian Embassy/Consulate. The department also forwards the list of foreign/NRI students admitted along with the required documents to the relevant ministries like Ministry of Health & Family Welfare (MOHFW), Ministry of Human Resource Development (MHRD), Ministry of External Affairs (MEA), Government of India (GOI) to obtain the 'No Objection Certificate' (NOC) for the students to pursue their higher education at KAHER.

Categories of International Students

- g) **Foreign Students:** Students holding passports issued by foreign countries including people of Indian origin who have acquired the nationality of foreign countries.
- h) **Non-Resident Indians (NRI):** Student with NRI status; students who are Indian citizens but have written their qualifying examination (equivalent to the 10+2) from a school or college abroad
- i) **NRI Sponsored Students:** Students are Indian citizens, whose immediate family member (parents, parents' siblings or students' siblings) is an NRI
