KAHER regularly conducts various knowledge events in the form of seminars, workshops, conferences etc. for undergraduates, post graduates, Ph.D. scholars & teaching faculty in research enabling them to explore new horizons and the unexplored arenas. Around 106 workshops have been conducted.

- Intellectual property rights related issues are dealt by external experts as well as in-house faculty on themes included patentability, the cost involved in patenting and the need for an IPR cell.
- Research Methodology course/ module/ workshops are incorporated in most of the programs offered at KAHER. Handson-workshops are organized to simplify concepts like research hypotheses, research objectives, study design and choice of statistical tests. Practical session for literature search and reference management is also included. Mentoring for preparing research protocol, data analysis and scientific communication is done.
- Research Grant writing workshop focus on identification of research topic, funding opportunities and development of grant application.
- Industry-academia interaction are conducted by trained professional from Pharma Industries IPR, patent issues, industrial perspective of drug regulatory affairs, translational research planning and execution etc.
- Training programs are conducted on recent advances and techniques in the field of Pharmacy, drug collection, standardization, licensing of drugs, GCP, GLP and hospital quality assurance practices by invited experts.

6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilization of resources

KLE Academy of Higher Education and Research is primarily a self-financed Institution and manages its own resources. Its policies are largely governed by UGC and various statutory councils. Funds are generated through tuition fees, funded projects, funded research projects, clinical trials and through hospital services and schemes.

The Board of Management and finance committee of the University ensure optimum utilization of assets. All constituent colleges prepare their budget for expenses regarding academic activates, salaries, research and augmentation of infrastructure. The financial planning & position of the university is deliberated upon in the meetings of these boards. Based on the needs and availability of resources, prioritization is done and all of which are dependent on effective financial resource management (capital budget and operational budget).

Major internal resource mobilization is through fee collection (registration fees, tuition fees, transfer fees, migration fee, annual fees, processing fees, medal deposit, donation, examination fees, fines and penalty, evaluation fee, convocation fee, sports etc.) and external revenue generation is through, research funds and income by consultancy services. Other sources include schemes by government on certain treatment facilities at hospitals, grants received for conduct of educational / professional programs, and some philanthropic donations towards hospital food services.

6.4.3 - Institution conducts internal and external financial audits regularly

One of the hallmarks of KAHER is its adherence to strict financial discipline. Budgeted expenditure is only permitted. Standard operative procedures as specified in the rule book and bylaws are followed for expenditures.

Internal audit: The Institute has own internal audit mechanism (ongoing process) to verify and certify the income - expenditure and the capital expenditure of KAHER each year. A thorough check and verification of all vouchers of the transactions of each financial year are carried out by a team of staff supervised by qualified internal auditors from external resources appointed permanently. The income and expenditure details are thoroughly verified and the compliance report is submitted to the University and to the principals of constituent units.

External audit: An external audit is carried out systematically once a year. The chartered accountants audit the accounts of the University as per the government rules. For any queries the supporting documents are made available within the prescribed time limits. Precautionary steps are taken and rectification is done immediately when minor errors of omissions and commissions are pointed out by the audit team and care is taken to avoid such errors in the future.

Waste Management & Disposal: Bio-degradable and Non- Biodegradable waste are segregated and appropriately disposed as per SOP's. Institution has MOU with 'Belgaum Green Environment Management Pvt. Ltd' approved by Karnataka State Pollution Board for its disposal.

Biomedical Waste Management: OSHA standards are followed to manage biomedical waste generated at hospital by segregation in color coded bags, collection, transportation, storage, treatment and disposal. Bio hazardous waste is incinerated. Heat produced by combustion of biomedical waste in the incinerator is used to heat up boilers. Steam produced is used in laundry and kitchen.

Organic waste segregation, disposal and recycling: kitchen and

garden litter are converted to compost at vermicompost units in the campus. Paper Waste Gets shredded.

Liquid waste is channelized into disinfection units and treated. Sewage treatment plant (2000 m3/day) helps to treat the waste generated from hospital. Domestic water waste is treated using activated sludge process by extended aeration system. Thus, treated sewage after chlorination is pumped for gardening Recycled water and waste water of RO system is used for flushing toilets, cleaning and gardening. E-waste,

Hazardous chemicals and Radioactive Waste is managed through different storage chambers. AERB certification for all X-ray units.

The cell has been focusing on making empowerment a process rather than a product by bringing awareness on equal opportunity and privileges to women. All teaching, nonteaching women of the Institution are members of the cell.

The objectives primarily focus on:

- Main streaming the gender perspective in the development process.
- Elimination of discrimination and all forms of violence against women.
- Building and strengthening women through women cell activities.
- Employment, financial independence and making them selfreliant and confident.

3. THE CONTEXT

- To provide a safe environment for learning for female students and working women in the campus
- Empower the female staff and students on different perspectives of gender issues
- To create a culture free of bias, stereotypes, discrimination and promote gender equality.

4. THE PRACTICE

- The cell has extended health care initiatives such as screening camps on breast cancer, cervical cancer, hepatitis vaccination etc.
- An Adolescent education program is one of the notable highlights of the cell.
- A unique initiative of the cell is segregation and treatment of organic waste using home decomposting kits and vermicomposting units.
- A game of giving app facilitates and provides a forum for donors and the recipients.
- Covid 19 was an exceptional challenge .The cell undertook the running and maintenance of an isolation center. It also upheld the motto of vocal for local for the benefit of vast

- number of local MSME's amidst the economic crisis created by the pandemic.
- The cell provides hospital equipment for home care through its hospital equipment project.
- Wee care is an initiative that facilitates day care for wards of female employees.
- Social outreach programs to the deprived women population such as jail inmates are organized
- Toilet for girl child was constructed in a government girls school to prevent open defecation.
- An internal complaints committee, grievance and redressal and sexual harassment prevention cell of KAHER constituted as per UGC / Vishaka guidelines. Redressal is done in an amicable and legally acceptable manner.

- Almost zero complaints related to abuse has been noted on account of active and vigilant grievance and redressal cell.
- The most commendable outcome was quick and legal hearing and pronunciation of death verdict to the accused in an gruesome rape case involving a minor. This was in response to the memorandum submitted by our cell to the Prime minister's office..
- A good number of asymptomatic breast cancer cases were revealed in the breast cancer camps conducted where more than 2500 patients were screened. This facilitated early intervention and treatment for the individuals affected.
- The cell also published the observations of the breast cancer screening camps in a peer reviewed journal.
- A cleaner and greener campus on account of the vermicomposting project

6. PROBLEMS ENCOUNTERED AND RESOURCES REQUIRED

- A major headwind faced is the reluctance of some women employees to participate in the cell activities fearing social taboos.
- They are also at times not forthcoming on want of confidentiality about their grievances.

COVID 19: Transforming the Challenge in to an Opportunity

COVID 19 pandemic bought in many adaptive and transformative challenges. Health care education, economy and all walks of life were adversely affected. Institution was fortunate toturn this challenge into an opportunity both in teaching-Learning as well as healthcare.

Teaching training: With the sudden unprecedented lockdown got education Institutions to adopt to new normal. Use of technology, LMS, trained faculty to develop & deliver online contents, engaged students in virtual teaching sessions.

Health care: Huge hospital infrastructure required immediate formation ofcore groups and protocol and guidelinesdevelopment. We were the first to start COVID testing in private sector. We trained faculty, created isolation areas with critical care equipment's, safety kits, O2 etc. More than 75000 tests were conducted, 7000 plus patients were admitted and most of them were treated successfully. Apart from this involved COVID research, 45 COVID related publications, COVID vaccine & number of drug trials that were conducted in the hospital. The colleges undertook a number of awareness programs, worked in community and were actively involved in vaccine campaign.

All our efforts in this regard were appreciated by District and State authorities, NGO's and various organizations.
