- 5. From the college end make arrangement to send SMS on 18th July 2022 to every candidate and their parents regarding the availability of online exam application and payment without fine from 19th to 24th July 2022.
- 6. From the college end make arrangement to send reminder SMS on 25th July 2022 to every candidate and their parents regarding the availability of online exam application and payment with fine from 25th to 29th July 2022.
- 7. Attendance: Please furnish the attendance of candidates by calculating the attendance up to the last working day of the course/term. There is no provision for Condonation of Attendance.
- 8. Shortage of Attendance: Application Forms should not be issued for those students whose attendance is less than 80%.
- 9. Evaluate the eligibility of the superspeciality candidate as per MCI regulation 2000 (Amended upto May, 2018) published in part III, Section 4 of Gazette of India dated the 7th October 2000 (page 39) 13.9 to make him/ her eligible to appear for KAHER examination.
