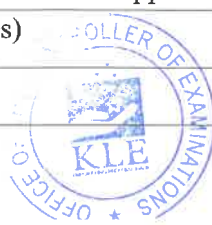



### Instructions to the Principal / Heads of the Institution

6. From the college end make arrangement to send reminder SMS on **27<sup>th</sup> May 2022** to every candidate and their parents regarding the availability of online exam application and payment **with fine** from **27<sup>th</sup> May to 1<sup>st</sup> June 2022**.
7. *The Head of the Institution should not encourage enrollment of the candidate/s for University examinations after the scheduled due date of filling of examination forms. The Institution has to strictly follow the examination scheduled time line.*
