Various Faculties (Medical, Dental, Ayurveda, Pharmacy, Physiotherapy, Nursing, Homoeopathy) being available in one single campus has been an advantage. Hence, there are a total of 272 interdisciplinary courses offered by the constituent colleges including the newer ones on AI. Also, undergraduate programs in Hotel Management and School of music have been unique in providing added value to the interested students. The interdisciplinary teaching-learning process integrates two or more disciplines and facilitates T-L and research of complex problems that cannot be tackled by a single discipline. The courses are trying to harmonize the links between disciplines into a coordinated and coherent system. Combined Views of different disciplines are being offered for interdisciplinary research and PhD program.

16.Academic bank of credits (ABC):

- NAD and ABC are on same portal.
- As per the directions of UGC (Circular No. D.O. No. F.1-3/2017(NAD/MHRD), the University has uploaded Students Degree Certificates (Total Numbers 14766) and Provisional Degree Certificates (Total numbers = 1219) on the National Academic Depository (NAD), Digilocker till date to safely store and publish the Academic Records and also to validate and guarantee its authenticity.
- The University has also directed all the students of KAHER University to register on the Academic Bank of Credit (ABC)-NAD Portal and receive their ABC IDs. In this regard total of 6457 students have registered on ABC portal. This facility enable the students to access their academic awards and verify the same.

17.Skill development:

The curricula are developed within the broad frame work of various regulatory councils (MCI/ NMC, DCI, PCI, INC etc.). While the programs are in accordance with the respective statutory and regulatory councils, there are many values added courses to enhance skill. Institute has developed skill labs in constituent colleges. An advanced Hi fidelity, Hi tech simulation skill lab in the campus helps the students to hone their clinical skills. The students' postings in the hospitals and peripheral centers, help the students to deal with real life skills. Also, much emphasis is laid on development of technical skills, soft skills like communication, counselling, leadership, decision making etc. The state-of-the art equipment and task-trainers in Hi-tech Hi-

fidelity simulation center & clinical skill labs are ensuring critical skills development and enhancement. All programs have mandatory internship that provides hands on experience to understand the prerequisites needed for a start-up entrepreneurship in their respective fields.

The advance Clinical Skill lab also has trained Students of KLE 8th, 9th and 10th std from all KLE Schools, students and adjacent colleges of Physiotherapy and Nursing in Basic Life support. The lab will soon be training external organizations like Police, Army, Fire brigade, airport authorities and City Corporation.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

KAHER Deemed-to-be-University represents National culture. The students from different states, with different ethnicity, gender, culture, region, background etc. are admitted to various programs. Institution therefore makes it a point that there is harmony, understanding and respect for each other. The curricula are framed keeping in mind the broad regulatory guidelines as well as local, regional and global needs and to make the students globally competitive. Institution also organizes classes of regional language for out state students which exposes them to local traditional beliefs. Students learn from each other about their culture, language, food hobbits etc. and co-existence. Yearly organization of cultural and sports events at colleges encourages the students to showcase their traditional values. NSS has adopted 11 villages that exposes students to the rural setup. Women Empowerment cell conducts cultural events for all teaching and non-teaching staff that provides platform for cultural and lingual conglomeration. The International students' cell organizes events for International students that benefits exchange the tradition and values among all students.

Students also actively participate in National Integration camps, that brings coherence and teaches them unity. Additionally, The College of Ayurveda has Ayurveda scripts in Indian Language, Sanskrit that enables the students to learn traditional healing.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The course curricula for all programmes are dynamic. All the curricula have PO's and CO's with are Specific, Measurable, Attainable, Relevant and Time bound that fulfils local, national

& global needs. The Institute has well-defined PO's and CO's for all UG programs.

The faculty of Pharmacy has implemented Outcome Based Education (OBE) since 2015. Internal assessment and question papers are aligned with course outcomes which provide a strategic way to enhance the quality of teaching and learning. As a quality initiative by Academic Affairs and IQAC, all constituent colleges are trained to frame PO's and CO's for bachelor programmes with attainment levels calculated on trial basis. The outcomes for every course have been mapped to program objectives. Regular faculty development programs are conducted for training faculties for OBE.

The Faculty of Medicine has implemented Competency Based Medical Education Curriculum since August 2019, which is designed to create a competent and skilled Indian Medical Graduate. The faculty of Nursing has implemented Competency Based Nursing Education since 2021. The Faculty of Ayurveda has reframed the curricula based on new guidelines by NCISM since 2023.

20.Distance education/online education:

Being a health science Institution, the curricula for all programs require in person training. However, Institution has ICT infrastructure that enables technology based teaching learning practices across all the constituent units for all its programs. The Wi-Fi enabled campus, broadband internet access, LAN system, lecture halls and equipped with LCD projectors, smart classrooms with interactive whiteboard, projection display aid in online mode of education. The Institution has lecture capture system and teaching content development studio's that generates video content of classroom lectures which are accessible to students through a dedicated online portal. Students can access the lecture videos anytime from anywhere, including from hostels and off campus locations. The videos/lectures can be viewed in their entirety or any selected section for quick reviews and revisions. More than 10000 customized e resources are available for students that supports lecture, clinical and practical demonstrations. Many of the value added courses are in hybrid mode.

• Students also utilize the services of online e-resources like NDL and SHODHGANGA and e resources that are in Central library. Various online platforms such as Zoom, Go To Meeting, Google classrooms etc. are extensively used for online/remote learning. This was particularly useful during COVID 19 pandemic when the students were off-campus. The Pharma programs use Computer Based Simulation experiments and software's like Expharma, Micromedex, Design of Experiments, Molecular modelling software, etc.

The process begins with online exam notification, form filling, fees payment and hall ticket generation. On screen Question paper (QP) setting/moderation based on Robust Pre-Validated E-Question banks occurs through in house software. QPs are generated using standardized Blue prints. The encrypted and pass word protected QPs are electronically distributed to Exam centers. Students' exams are on Electronic pads. This enables Item analysis of objective questions and matching of program & course objectives with outcomes. On-screen evaluation; Double valuation, up to three valuation (difference more than 20%) for undergraduate and up to four valuations for postgraduate courses (Medical and Dental) is practiced. Model key answers and Analytical scoring rubrics make our assessments more valid and reliable. Modern tools like OSPE, OSCE, Mini CEX, etc. are utilized. Examiners' appointment, remuneration bills is through software. E-feedback is sought for Quality assurance. - Live Video telecast of Body Dissection from Cadaveric Lab to the adjacent Demo Room.
- Contineo software allows faculty to upload their presentations which students can access by logging into their individual accounts.
- The studio at Community radio station 'Venu Dhwani' 90.4 FM provides recording facility.
- The Department of Art & Photography has facilities for Photography and Video recording.
- The halls in the Auditorium have state-of-art Sound systems and are popular venues for recording concerts, plays, orchestras, etc.
- Ayurveda college has established ICT Enabled Teaching Content Development Studio (KLE AYUR studio) equipped with top-spec computer hardware and high-end video editing tools. 15 e-courses with 381 videos have been uploaded on the NCISM portal.

The institution has a well-developed, well-structured performance appraisal system for its teaching and non-teaching staff. It includes both a holistic overview and an objective approach for the performance of an individual. It helps to assess the application of knowledge, ability to perform, handle responsibilities at work, and demonstrate skills and ability to complete tasks.

Performance appraisal system for teaching staff

The performance appraisal system for teaching staff is as per the policies for regularization of staff, timely increment, incentives, leave facilities, and promotion.

The performance of all the employees is reviewed on various parameters like knowledge, skills, expertise, experience, discipline, work output in terms of clinical services, publications, funded projects, students and peer feedback, etc.

Performance appraisal system for non-teaching staff

Non-teaching staff are assessed by obtaining a confidential report from the HOD or unit in charge for the yearly increment. The report includes discipline, efficiency, dedication, and improvements in abilities.

Based on the performance appraisal analysis, recommendations for yearly increment and/or promotion and continuation of service are finalized. The employees who do not fulfill the requirements are encouraged and trained to attain the required competencies.

6.4 - Financial Management and Resource Mobilization

6.4.1 - Institutional strategies for mobilisation of funds and the optimal utilization of resources

KLE Academy of Higher Education and Research is primarily a selffinanced institution and manages its own resources. Its policies are largely governed by the UGC and various statutory councils. Funds are generated through tuition fees, funded research projects, clinical trials, and through hospital services and schemes.

The Board of Management and finance committee of the institution ensure optimum utilization of assets. All constituent colleges prepare their budget for expenses regarding academic activities, salaries, research, and augmentation of infrastructure. Based on the needs and availability of resources, prioritization is done, all of which are dependent on effective financial resource management. The strategic plans have tried to balance between external funding challenges and the ongoing necessary internal improvements to sustain and enhance the quality measures.

Major internal resource mobilization is through fee collection (registration fees, tuition fees, transfer fees, migration fee, annual fees, processing fees, medal deposit, donation, examination fees, fines and penalties, evaluation fee, convocation fee, sports, etc.) and external revenue generation is through research funds and income by consultancy services. Other sources include schemes by the government on certain treatment facilities at hospitals, grants received for the conduct of educational/professional programs, and some philanthropic donations towards hospital food services.

6.4.3 - Institution conducts internal and external financial audits regularly

KAHER strictly adheres to financial discipline. Standard operating procedures as specified in the rule book and bylaws are followed for expenditures. Compliance for financial transactions is ensured by an established mechanism of internal and external audits per year. Audited statements are placed for approval to the BoM.

Internal audit: The Institute has its own internal audit mechanism to verify and certify the income-expenditure and the capital expenditure of KAHER each year. A thorough check and verification of all vouchers of the transactions of each financial year is carried out by a team of staff supervised by qualified internal auditors from external resources appointed permanently. The income and expenditure details are thoroughly verified and the compliance report is submitted to the Vice Chancellor of the University and to the principals of constituent units.

External audit: An external audit is carried out once a year. The chartered accountants audit the accounts of the University as per the government rules. For any queries, the supporting documents are made available within the prescribed time limits. Precautionary steps are taken and rectification is done when minor errors are pointed out by the audit team, and care is taken to avoid such errors in the future.

7.1.3 - Describe the facilities in the Institution for the management of the following types of degradable and non-degradable waste (within 100 - 200 words)

KAHER has standard norms for effective waste management by 'Reduce, Reuse and Recycle'.

Waste Management & Disposal: Bio-degradable and non-biodegradable waste are segregated and disposed as per SOP's. The institution has an MOU with 'Belgaum Green Environment Management Pvt. Ltd' approved by Karnataka State Pollution Board for its disposal.

Biomedical Waste Management: OSHA standards are followed to manage biomedical waste generated at hospitals by segregation in colorcoded bags, collection, transportation, storage, treatment, and disposal. Biohazardous waste is incinerated.

Organic waste segregation, disposal, and recycling: kitchen and garden litter are converted to compost at vermicompost units in the campus. Paper Waste will be shredded. Liquid waste is channelized into disinfection units and treated.

Sewage treatment plant (2000 m3/day) helps to treat the waste generated from the hospital. Domestic water waste is treated using an activated sludge process by an extended aeration system. After chlorination it is pumped for gardening. Recycled water and wastewater of RO system are used for flushing toilets, cleaning and gardening.

E-wasteis minimized by proper maintenance and repair. Damaged electronics are disposed to the vendor.

Hazardous chemicals and Radioactive Waste are managed through different storage chambers. AERB certification for all X-ray units.

Water treatment planthas a capacity of purifying 2.25 million liter/day. Similarly, soiled water is channelized to disinfection units before disposal.
