Resolved to take note of the same. While taking note of the same, the Advisory Committee suggested the following:

- Only those activities, for which the NSS volunteers are involved for conduct of the programs / activities / camps, are to be considered as NSS activities and only such activities are to be presented in future. The NSS Banner / Flag / Logo should be visible in the background in the group action photographs for documentation.
- The saplings which are planted in the respective institutional campus during Vanamahotsa / birthday celebrations of the faculty members are to be properly monitored for growth for a minimum of three years by the concrerned NSS volunteers.
- Swachh Bharat Abhiyan / Yoga Practice session / Digital Cashless Transaction
 Awareness Programs should be arranged in all NSS special annual camps in future.
- The programs and activities conducted during the camps are to be properly documented and the relevant records are to be kept in the respective institutions.
- The importance of water-rain harvesting / water conservation is to be impressed upon the public as an alternative source of water, as Karnataka State is reeling under severe drought for the last 2-3 years.
- The Principals / Vice Principals of the constituent units shall ensure that all NSS volunteers are involved for all NSS special camps / NSS regular activities and shall personally present at least for three days and ensure that at least one member of the Advisory Committee of the NSS is present during such camps to monitor the same. NSS volunteers in special camps should always be accompanied by a faculty member of the college on rotation and should not be left for themselves to prevent any untoward incidences.
- The unique activities / constructive works / permanent assets creation are to be taken
 up during the conduct of the special / regular camps after aseessing feasibility and the
 same is to be highlighted in the NSS Board/Advisory Committee meeting presentation.
- As far as possible, all the NSS programs / activities are to be conducted preferably during the evening hours (4pm-8pm) so that there shall be active participation by the community / villagers in the adopted villages during the NSS Special Annual Camps.
- The Principals of the constituent units are required to draw the advance and give the same to the concerned NSS Program Officers for conduct of the NSS Regular Activities. They shall ensure that the advances are settled within one month from the date of drawal of advance. The expenditure towards conduct of programs out of the

budgetary provision of the University and the financial grant received from the Government is to be strictly made as per the NSS guidelines issued by the Government and the University.

- The local constituent units in Belagavi may consider organizing health check-up camps in the Sambra Airport, for the benefit of its personnel and the in the Central Prison, Hindalga for the benefit of prisoners & jail staff.
- The NSS Units of the University may consider conduct of camps / awareness programs on Drug Abuse by the students, Food Adulteration, Medicines storage / generic drugs / Rational Drug Use / Benefits of proper handwash / First Aid Training, etc.
- Awareness about various Government health schemes available at KLE Hospital shall be given to the public in adopted villages in Belagavi taluka / Urban slums in the city.
- The Principals of the constituent units shall ensure that there shall be no repetition of the similar programs. Each NSS Unit shall develop their own thrust areas based on their rexpertise and strength.
- The Special NSS Unit-9 (Department of Public Health) shall conduct programs on health awareness programs like importance of Life Skills, drug abuse prevention, hand-washing, etc.
- The concerned Principals shall enter the three years of completed NSS Service of the NSS Program Officers / NSS Program Co-ordinator in their respective Annual Confidential Records for the benefit of the faculty after verification of records.
- Those NSS Programme Officers who have completed three Years of NSS Services
 are to be encouraged to apply for the University / State / National NSS Awards only if
 they have attended seven days' NSS Orientation training at the Regional NSS
 Empanelled Training Institute and organized minimum three Special Annual Camps.
