- Candidate is required to fill the application in the prescribed format & submit the same to the Principal of the concerned college with the prescribed
- The application is forwarded through the Office of the Principal of the constituent college to the Office of Controller of of Exam nations.

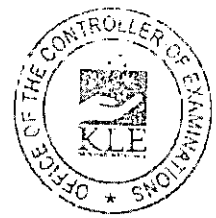
The photocopies of the answer booklet along with the marks masking the identity of the evaluator will be shown to the candidate. The schedule for viewing of answer scripts is intimated to the candidate in prior and the answer script is shown to the student in the presence of a University official under CCTV surveillance. After viewing the script the student will sign and submit an undertaking. If any assistance of subject expert is needed it shall be provided by the examination section. All data during this procedure are documented and preserved.
