The Registrar welcomed the members and informed that this meeting has been convened as per the directions of Hon. Vice-Chancellor to discuss and decide on various issues / matters relating to Examination Branch and increase in the annual intake of MPT courses.

The Agenda was taken up for further consideration and approval:

Item No.1: ***Consideration / discussion regarding dissertation problems / issues of the ongoing exam medical and dental students.***

Prof. S.S.Urabinavar, Controller of Examinations informed that the Post-Graduate Teachers (Guides) / External Examiners who have evaluated the dissertations submitted by the Post-Graduate medical and dental students have made certain observations as per the enclosed statements. In certain cases, the dissertations have been rejected by the Examiners. The observations / comments made by the individual examiners were read out in the meeting.

Resolution:

After detailed deliberations and taking into consideration the type of observations made by the Post-Graduate Teachers / External Examiners and also the Rules and Regulations of the Medical Council of India, the following resolutions were adopted:

a) Dr. Srikrishna Chaitanya K, M.S (Orthopaedics) - 2014-15 Batch:

After detailed deliberations, it was felt that the reasons for rejection are not serious in nature and the Examiner would have accepted the dissertation of the student with suggestions for corrections. It was resolved that a Committee of experts from the Department shall go through the dissertation and then refer the same to an external examiner for further consideration.

b) Dr. Katkar Akash alias Pratik Pratap, M.S (General Surgery) - 2014-15 Batch:

In this case, the internal examiner has not done justice and rejected the dissertation. It was felt that being an internal examiner, he would have discussed the matter with the concerned HoD, Post-Graduate Guide and the Dean and taken an appropriate decision as regards to acceptance / rejection of the dissertation and also he should have known the serious implications of rejection of the dissertation of a PG student. It was resolved that a Committee of experts from the Department shall go through the dissertation and then refer the same to examiner for further consideration.

c) Dr. Avishkar Makal, MDS – 2014-15 Batch:

In this case, after detailed discussions, it was felt that the comments / suggestions made by the external examiner are genuine, barring a few, which would have been subjected for correction. It was resolved that a Committee of experts from the Department shall go through the dissertation and then refer the same to an external examiner for further consideration.

The Standing Committee of the Academic Council also adopted the following resolutions:

- To collect Rs.10,000/- per student towards dissertation resubmission charges.
- To accept only those dissertations for which the External Examiners clearly mention the acceptance of the same after resubmission. In case, the External Examiners suggests for revision of the same, the same should be rejected.
- To issue warning letters to the Post-Graduate Teachers (Guides). Any such lapses in future by Post-Graduate Teachers (Guides) will have to be viewed seriously by the University with heavy penalties.
- To place the same in the forthcoming meeting of the Academic Council of the University for ratification.

Item No.3: ***Consideration of enhancement of PG seats in Physiotherapy at KLE Institute of Physiotherapy, Belagavi***
