Category of Research Scholars: (for details please refer to Annexure – III)

Full Time : *Eligible candidate from any place in India.*

Part-Time : *Faculty from Constituent units of KAHER, Belagavi, Hubballi & Bengaluru.*
(Eligibility for Part-Time minimum completion of one year of service at KAHER)

For off-campus, Hubballi & Bengaluru: Pre-Ph.D. Orientation classes at Hubballi & Bengaluru will be conducted only if 3 or more scholars register at respective units, if not, then the scholars will have to attend these classes at Belagavi.

Mode of selection of candidates:

The selection of the candidates will be based on the merit obtained at the Entrance Examination and on the performance of the candidates during the *interview to be conducted* by the Ph.D. Admission Committee of the University.

Grant of financial assistance (monthly stipend & contingency)

to Full Time Research Scholars:

*Based on the recommendations of the competent authority / Committee, the University shall consider extending financial assistance to the deserving **Full time Research Scholars** in the form of scholarship and contingency as given below:*

** Scholarship will be granted for a period of thirty three months subject to clearance of Pre-Ph. D. Examination in first attempt.*

** Candidates receiving financial support from any other agency **will not be eligible** for the scholarship and contingency.*

Terms and conditions:

- (i) The Research Scholars shall strictly adhere to the existing Rules and Regulations of the Ph.D. Program of the University.
- (ii) The University will not bear any expenditure towards conduct of the Research work, which has to be borne by the individual, but can use the available physical infrastructure and library facility.
- (iii) The Research Scholars are not permitted to register for any other academic program of Indian / Foreign University during the tenure of the Ph.D. course.
- (iv) The Research Scholars shall attend all the seminars and orientation programs conducted by the University/Departments relating to their research topic / project.

- (v) A separate log book needs to be maintained by all the Research Scholars and the same should be made available as and when required by the University.
- (vi) The Research Scholars working in any of the KLE Institutions are required to give an Undertaking to the effect that they shall serve the KLE Institution at least for a **minimum period of two years** after the completion of their Ph.D. Program.
- (vii) In case the Research Scholars wish to discontinue the program, their registration gets cancelled and such Research Scholars are liable to pay the entire course fee.
- (viii) In case the full-time Research Scholar who receives the financial assistance from the University, fails to continue the *Ph.D. Program*, shall refund the entire amount to the University.
- (ix) Full time Ph.D. Research Scholars may be assigned work upto 6 hours per week by the Principals of respective constituent units.
- (x) Change of work place shall not be permitted during the Ph. D. Course.
