# Guidelines for KAHER Best Ph.D. Thesis Award

### 1. Objective and Scope:

- To enhance and recognize the quality research work done by the Research Scholars of the KAHER.

#### 2. Scope:

The Research Scholars who have submitted high-quality thesis leading to acceptance of Doctor of Philosophy (Ph.D) Degree by the KAHER.

#### 3. Name of the Award:

'KAHER Best Ph.D. Thesis Award'.

#### 4. No. of Awards:

The KAHER shall consider maximum two awards (For every 10 Thesis 1 Award) per year, in research related to health science.

#### 5. Quantum of Award:

The KAHER shall give a Certificate and cash award of Rs.20,000/- (Rupees twenty thousand) for each Awardee.

# 6. Eligibility:

- Any Research Scholar (Full Time / Part Time) who has submitted high-quality thesis leading to acceptance of Doctor of Philosophy (Ph.D) Degree by the KAHER.
- The research work must be original and must have a direct bearing on some relevant aspects in the area / discipline of health science / patient care / any relevant field.
- The results obtained from the research must have the potential of enhancing the quality of health science / patient care / any relevant field.
