**REFUND POLICY for Round 1:** The Amount of Rs. 12,000/- (*processing charges*) will be deducted in case of **seat up gradation from first round to second round** or in case of candidate resigns during the counseling period and such withdrawal should be within last date of MCC withdrawal Schedule.

*Note: in case of refund of fees against cancellation the amount will be credited to candidates account only with valid PAN number.*
