**AGAINST UNFILLED MANAGEMENT / PAID SEATS (UR)**

**(Deemed University – Stray Vacancy Round)**

In accordance with the directions of the Ministry of Ayush / Ayush Admissions Central Counselling Committee (AACCC), the KLE Academy of Higher Education and Research (KAHER), Belagavi will be conducting a stray vacancy round of counselling for admission to the vacant seats in Under-Graduate BAMS / BHMS courses at the following constituent units (institutions):

- 3) Candidates attending counseling should satisfy the eligibility requirement as per the NEET Information Brochure – 2023 / AACCC and the minimum eligibility requirements as prescribed by the Ministry of AYUSH / AACCC for admission to BAMS/BHMS courses respectively.
- 4) **Please note that the candidate should come along with original documents as per ANNEXURE-I along with the prescribed fee in the form of Demand Draft/RTGS/NEFT as detailed on the website without which admission will not be given.**
